Responding to abuse and neglect

(formerly known as mandatory notification)

Every child has a right to be safe from harm at all times. The well being and best interests of children are the responsibility of the entire community. All people volunteering in preschools and schools have responsibilities in reporting abuse and neglect. Dept for Education and Child Development (DECD) preschools and schools have a responsibility to ensure that their volunteers know about those responsibilities.

In this session you will find out about your responsibilities as a volunteer, what child abuse is, how to recognise it, what to do and how our schools expect adults to behave around children. The session will take approximately two hours. Parent groups and clubs

We can provide formal information sessions to a group of parents or informal information to an individual or a few parents on any topic about parent groups/clubs including

- what is a parent group
- how a parent group can operate
- how to conduct meetings and good practice
- role of officers
- financial operation of a parent group
- role of parent group representative on school/governing council and budget committee
- developing a constitution which is a requirement for all affiliated committees (which includes parent groups)



Merit selection panels for principal and director positions

When a vacancy occurs in the position of principal or preschool director the governing council or management committee nominates a parent to be on the selection panel. It is vital that the parent taking on this role understands and is comfortable with the process. This session is run in particular for those nominees but it will provide members of the wider school community with the opportunity to understand the appointment process.

You will learn about the processes which will occur and the roles and responsibilities of the parent nominee on the selection panel. The session will take approximately three hours.
